MEMORANDUM OF UNDERSTANDING

Subject to the terms and conditions of this MOU, the Party of the other part shall act as an independent entity and nothing in the MOU shall create or be deemed to create a relationship of principal/agent, employer/employee or joint-venture between the Parties and the relationship between **RCF** and JSM College is that of Principal to Principal basis. JSM College is not authorized to assume or create any obligation or responsibility, including, but not limited to, obligations based on warranties or guarantees or other contractual obligations, on behalf or in the name of the RCF and vice versa.

II. OBJECTIVE

RCF and "**JSM College, Alibag**" shall provide on hands on practical training to the students of **JSM College** with the following activities:

- A) Managerial / Secretarial Training
- B) Summer Internship Training
- D) Academic Partnership
- E) Guest lecture Sessions
- G) Training for gender equality & women's empowerment through Ethics
- I) Field visit of Industry
- J) Management Development program for students

III. IMPLEMENTATION PLAN:

A. Managerial/ Secretarial Training

A three full day hands-on managerial and secretarial skills workshop may be held at RCF premises for 25 students from **RCF Ltd.** to allow students to gain valuable practical experience.

The hands on domain workshop training will be conducted by RCF experts and a certificate of successful participation will be issued by RCF to the students.

B. Summer Internship Training

Summer Internship Training with a minimum of Ten Students from any discipline under any course will be provided on chargeable basis at RCF Ltd. Thal campus for gaining on job experience, in the field related to academics and science. V. TERMINATION:

Either party reserves the right to terminate this MOU with a prior written notice of not less than 30 days.

VI. JURISDICTION:

The MOU is governed by and constructed in accordance with the laws of India. The parties shall submit all their disputes arising out of or in connection with this MOU to the exclusive jurisdiction of the Court of Mumbai

VII CONFIDENTIALITY:

The Parties, to the extent of their respective rights to do so, shall exchange such information and data as is reasonably required by each Party to perform its obligations and responsibilities under this Agreement. Each Party agrees to keep in

confidence and to use the same degree of care as would do with respect to its own proprietary data to prevent disclosure to third parties of all technical information, data and confidential business information.

VIII Duration:
